PURPOSE

This policy explains how Marnebek School proposes to manage common enquiries from parents and carers.

SCOPE

This policy applies to school staff, and all parents and carers in our community. All communication among the school, parents and students will be respectful and professional, underpinned by appropriate privacy and confidentiality principles.

POLICY

Marnebek School understands the importance of providing helpful and timely responses to common enquiries from parents and carers. To ensure that members of our school community are directed to the most appropriate person to assist them, the information below outlines key contacts for common queries:

Compass is Marnebek School's main communication platform between parents/carers and the school.

Social media apps, Seesaw and the School Bulletin are used to share news, student work, and promote and give reminders about upcoming events. They should not be used to communicate or raise any matters relating to your child.

To ensure that members of our school community are directed to the most appropriate person to assist them, the information below outlines key contacts for common queries to:

- report a **student absence**: in the first instance, please use the Compass app or alternatively leave a voice message on the absence line on 59963858 choose option 1
- report any **urgent issue**s relating to a student on a particular day, please contact administration office on 5996 3858
- discuss a student's academic progress, health or wellbeing, please contact your classroom teacher/Learning Neighbourhood Leading Teacher via email using the Compass App to make a time to call or meet. In the email, parents should briefly outline what they wish to discuss and if required, request a meeting with the teacher to discuss the matter in more

detail. Teachers will always endeavour to respond within 24 hours. Teachers can also be contacted before school from 8:30-9:00am, or after school from 3:00- 3:30pm to speak with you personally alternatively, the school admin team can put you through to the teacher's voicemail. For enquiries regarding camps, please contact the camp organiser. This information is available from your child's Compass Camp Event notification.

- enquire about an excursion, please contact your classroom teacher.
- Raise a concern, please contact the Assistant Principal of your child's Learning Neighbourhood on 5996 3858. Please also refer to our Complaints policy, available on our school website
- report a potential hazard or incident on the school site.
- ask about a parent payment, please ask to speak with the Finance Officer.
- ask about student transport (buses) please ask to speak with the Student Transport officer.
- make enquiries in regard to any other matters please call the Administration Office 5996 3858
